The primary responsibility of these positions are to provide psychological counseling to the BU student population, including intake assessment, individual and group counseling, emergency assessment, crisis intervention, outreach, referral, timely completion of clinical documentation, and related duties within the Department of Counseling & Human Development. Counseling Faculty also engage in activities of Service to the University and the surrounding Community and maintain ongoing Professional Development activities.
